AGENDA ITEM: Outdoor Recreation Fund Advisory Council Funding Update

ACTION REQUIRED: Approval of Proposed Motion

BACKGROUND INFORMATION:

Senate Bill 1196 (FY2024) appropriated \$95 million from the State's General Fund to IDPR's Parks and Recreation Fund, to be used exclusively in the Capital Development Program to address new capital projects and the extensive backlog of deferred maintenance. Executive Order 2023-03 was signed by Governor Little and established an Outdoor Recreation Fund Advisory Council, otherwise known as ORFAC. The executive order allocated \$5 million from Senate Bill 1196 to be used for projects selected by ORFAC, the Governor and the IDPR Board.

Senate Bill 1383 (FY2025) added \$5 million to ORFAC utilizing American Rescue Plan Act (ARPA) funds, currently appropriated in IDPR's budget. ARPA funds were required to be obligated by December 31, 2024 and all work completed no later than December 31, 2026.

The following is a funding obligation update for the ORFAC General Fund, and, ORFAC ARPA funded projects.

IDPR fiscal has released all funding for the above projects that are under contract and in compliance with any additional leftover funds from the initial obligation, totaling \$4,811,448.00. The remaining balance of the projects (in green) were reallocated to the Horsethief Reservoir project.

Staff is considering re-budgeting the \$155,850.00 in projects to the ORFAC General Fund program. Assuming the \$155,850.00 is moved into the General Fund ORFAC program, the balance remaining will be \$373,850.00.
