Application must be received by Lucky Peak State Park no later than 5 working days prior to date of use, or at the time of payment due for an associated event reservation, whichever comes first. Application does not mean approval.

Alcohol Permit Policies

- It is understood that all state, county, and city laws in regard to alcoholic beverages will be obeyed.
- It is understood that alcohol will not be sold or vended in any fashion, or be the basis to solicit donations, contributions or any form of payment.
- All laws are strictly enforced. All persons attending a function are subject to park policies. Offenders are subject to ejections from the park and/or prosecution. Should persons be ejected from the park or otherwise cited for violations of any activity associated with alcohol use, the permit may be revoked by the responding officer, the alcohol confiscated, and/or the group disbanded. In the event the alcohol use authorized by this permit results in the violation of any of the permit or reservation conditions, the individual representative(s) and the group named on this permit will not be granted another permit for a one-year period from the date of the infraction.
- The applicant(s) will be responsible for the actions of the participants and is required to be present with this permit during the entire time alcohol is present at the function. Should the applicant leave the area of the function, for any purposes, this permit is revoked.
- Permits issued are ONLY valid during the date and time period listed on the permit.

Any alcohol quantity more than 7.5gallons (i.e. keg) must be accompanied by approved permit and all other permits (issued by vendor) at time of park entry. YOU MUST NOTIFY PARK STAFF UPON ENTRY. They will check and fill out the required information in order to validate this permit.
