Check In

To facilitate late arrivals, it is not necessary to check in before going to your cottage. You must call ahead to get the key code that will give you access to the keys. Please lock the cottage while you are out enjoying the park. At the end of your stay, please leave the key on the kitchen table and lock the door behind you.

Accommodations

Each two bedroom cottage sleeps up to eight people. Renters supply their own full size sheets, pillows, blankets and towels. Cottages are complete with full bath, kitchen, dining area, and living room. Cooking utensils and tableware for eight are included. Kitchens have microwaves and coffee makers.

Entrance Fee

A Motor Vehicle Entrance Fee (MVEF) is required for all vehicles entering the park to use the day use areas, campgrounds, cabins and cottages. Fees collected at time of reservation accommodate only one Motor Vehicle Entrance Fee. If you have more than one vehicle all others must pay the MVEF upon arrival at the park.

Directions to Lakeview Cottage

Travel 6 miles east on Hwy 5 from Plummer, ID. At the bottom of the steep hill, watch for Chatcolet road. Stay on Highway 5. Turn on Hawley's Landing Road, 100 yards east of Chatcolet Road. Stay to the right until it dead-ends at the Lakeview Cottage.

Directions to Rocky Point Cottage

Travel 7 miles east on Hwy 5 from Plummer, ID. Turn left on Rocky Point Loop Road, 1 mile east of Chatcolet Road. The cottage is the 5th on the right.
