Call to Order

Skylar Jett called the meeting to order at 2:03 p.m.

Welcome

Skylar Jett welcomed Idaho Outdoor Rec Council to the September meeting and went through the room and on zoom for introductions.

Outdoor Recreation Survey

Robert Jones with GS Strategy Group presented an overview of the survey result that his group and some others put together. Topics covered were the profile of participants, environmental issues facing Idaho, Idahoans thoughts on the need for more funding for recreation, how Idahoans feel public land is managed, and how additional funding should be invested.

Criteria for Outdoor Recreation Projects

Susan Buxton gave an overview of the Outdoor Recreation criteria, application and the \$5 million in funds that was presented and asked for questions and concerns. Brocksom recommended adding location consideration and neighboring properties to the scope of work section. It was also recommended that match (in-kind) would be beneficial but not required. There were no other major concerns. Buxton will take the criteria to the IDPR board for final approval.

Skylar Jett asked if there was any other business to discuss. Mark Pratt mentioned that there is definitely a need for more education on public land use. Gretchen Hyde suggested a program to educate high school students about responsible outdoor recreation. Several members of the council agreed that education is important but didn't know if this fund should be used for education and if there might be other resources that can be used for funding education projects.

Jett also remarked that there has been a lot of interest in the council and asked how the group should hear from others in the community that want to be part of the conversation.

Director Buxton moved that the council invite other members of the community to come to the next meeting to have their recommendations heard by the council.
