I am a native Idahoan having grown up on a seed potato farm in eastern Idaho. I recently retired from 15 years' service to the Idaho Department of Lands (IDL). The last 10 years I worked in Coeur d'Alene at the IDL Bureau of Fire Management. My role as the Fire Business Program Manager, I was responsible for the agency's Fire budget, implementation of policies, funding, and auditing of Fire Suppression efforts for the state of Idaho, and Idaho Fire resources assisting nationally and internationally.
