Welcome and Introductions / Chairman Beckley and Director Buxton

Chairman Beckley and Director Buxton welcomed everyone to the meeting and asked for introductions.

Amend the Agenda

Mr. Roach motioned to amend the agenda to add Public Comment after Old/New Business. Mr. Roady seconded. The motion carried unanimously.

Director Update

Director Buxton explained the update to the reservation system and that people can still make reservations through 2024 on the original system, 2025 reservations will have to wait until January 6, 2025, to be available. Mr. Zaragoza explained that there will be a press release detailing the reservation system update. Mr. Zaragoza gave a shout out to Melanie Schuster for her hire as well as the 165 million dollars received. Mr. Elmore reported on the recreation bureau finishing up the boat and safety classes. Elmore state that the parks are moving full steam ahead and this is the busiest time of the year for them.

FY 26 Budget

Steve Martin presented the FY26 Budget to the IDPR Board. Martin said that the FY26 was identical to the FY26 that had been previously presented in May's Board meeting except for the following three items:

- IT (computer) replacement items increased from \$100,000 to \$197,500 based on input from the State's ITS department.
- DU 12.08 for \$400,000 in additional Federal grant spending authority was added based on an additional award anticipated for Lake Cascade.
- The \$900,000 enhancement request for the Horsethief Lake campground was removed.

Mr. Roach motions that the Board approve the FY 2026 budget proposal based upon the ranked replacement and enhancement items, for an estimated total of \$57,140,600, as summarized on page 2 of the attachment. Additionally, staff requests Board approval to adjust Health Benefit Costs and CEC, if any, to the actual amounts included in DFM's budget instructions when they are issued. Ms. Manning seconded. Chairman Beckley asked for a roll call vote.
